Can't get rid of that old car because you lost the paperwork? You were going to fix it, but never got around to it? Perhaps you don't have the additional money to have a tow truck pick it up or maybe you just want to remove the safety hazard and your neighborhood's eye sore?

As a public service of the Abandoned Vehicle Authority (AVA) Program, areas within unincorporated Riverside County can arrange to have the junk vehicle(s) removed from your property absolutely FREE of charge!

All you need to do is call Code Enforcement Administration and complete the form inside this brochure...we will take care of all the details.

**Contact Code Enforcement Administration, complete the form on the back and mail it to the corresponding address.**

**Program Benefits:**

- Absolutely FREE of charge!
- Cleaner and safer yard for you and your family
- Hassle-free process
- Friendly staff available to answer all of your questions

If you decide you want to keep the vehicle(s), you must:

- Store vehicle(s) in a fully enclosed and permitted structure; or
- The vehicle(s) must be fixed and made operable.

**Please Note:**

- Vehicle removals are reviewed on a case by case basis; not all cases are eligible. Based on Code Enforcement discretion.
- Legally mandated process can take approximately 45 - 90 days from start to completion.
- Boats, watercraft, and mobile homes do not qualify.
